Thoughts from the President

The last month has been a period of some progress. Perhaps the biggest event over the last couple of months was the meeting with Director James Dzurenda of the Department of Corrections. The Director reiterated the Department's support for the preservation of NSP. Specifically, he authorized:

- The Chief of Plant Operations to complete the application for change of use, when the code analysis is completed by the Dube Group [architects]. This will save money and time, and insure that the agency that controls the NSP property is involved in the process.
- The Director authorized limited tours for individuals who are potential donors to our activities to open the institution for public tours.
- He also accepted our draft of a revised Administrative Regulation 803, which would change the requirements for volunteers who work at NSP. The proposed AR does away with the requirement for TB testing, and "Prison Rape Elimination Act" training. There would still be a requirement for background checks and rule/safety training.

On May 17, I was able to meet with Don Bernard, the son and oldest child of Warden Art Bernard. He and his family lived in the Warden's House through the 1950's and were the last family to live there. He had some great stories and will be touring the institution in the next couple of weeks as a potential donor.

On May 24 there was a work session at the prison with Pete Dube and his staff. The expertise of NSPPS Board members Lee Perks and Maurice White helped us finalize the

tour route for the public and plan for ADA access to the facilities. This was really important as it is necessary to provide access, but keep the costs of changes to the buildings down. Pete and his staff are in the final stages of the code analysis and have had preliminary discussions with the State Public Works Board. This was a very positive exchange. The next step will be the application for change of use.

This last month Robin Bates arranged for me to meet Frank Adams, a Board member for the recently closed Peace Officers' Museum in Virginia City. Frank and his Board generously donated a laptop computer, and more importantly, their license for "Past Perfect" museum software. This software is specifically designed to document museum artifacts. This will add a professional element to our artifact acquisition. Frank is also interested in loaning an exhibit of artifacts from the State Police when we open. Some of you may not be aware that when the State Police was formed, the Warden was also the head of the State Police.

On the 1st day of June, Board member Terry Hubert and I got our string mowers and attacked the insidious weeds and grasses in the yard of the Prison. Hot and dirty work, but it needs to be done to protect the facility and put our best foot forward for potential donors. This week we will be working on the sucker trees growing up in the lawn in front of the Warden's House.

On June 5th, I gave a speech at the Carson Men's Club at the Empire Ranch Golf Club. This was a presentation on our progress for opening the institution. There was a clear understanding on the part of the member regarding the technical, bureaucratic process that we are faced with. This was our second presentation to this group.

On June 8th, the Footprint International Organization from Carson Valley presented our society with a \$1,000 donation. Ray Hoyt, formerly of the Gaming Control Board and NDI made the presentation with Douglas County Sheriff Ron Pierini. Sheriff Pierini is a former Officer, Investigator, and Trainer at NSP. He has also donated his stash of NSP artifacts to us. He has been a great advocate for us. I gave two presentations to the Footprinters this last year and hope to visit with them again. They are a great group that supports criminal justice agencies and their staff. We will be using this donation to advance the completion of the Public Works Board review of our change of use application.



Lastly I have heard from some discouraged folks regarding our progress at NSP. Frankly, at this time our preservation effort is almost entirely a bureaucratic one. We have to gain access before we can tour. It is intense, boring work, but we are going forward.

Membership

The month of June has been good. So far, we have received two Business memberships, as well as a few renewals.
